## A bit about us

- Danaher is associated with the RSPCA, but is an **entirely self-funded local charity**.
- We take in a variety of animals, mainly dogs, cats and small domestic animals, whether they be strays, pets whose owners can sadly no longer care for them, or cruelly treated animals rescued by inspectors.
- The home provides a temporary refuge where these animals are assessed, treated by our vets, cared for by our staff and volunteers and mostly rehomed to new loving homes.

## Benefits of leaving a gift to us in your Will

- We have been able to make plans to carry out important developments on site thanks to previous gifts. These include a new Rabbit House and an area for dogs to meet potential adopters in a 'home like' environment.
- There is NO inheritance tax on gifts left to charity.
- Inheritance tax payable is lowered by 4% if you leave 10% or more of your estate to charity.
- Leave a lasting memory of yourself, which will live on through our work.
- Animal Welfare is an issue that will never disappear. You can be assured every penny will go towards the care and rehoming of our animals.

## Types of legacies

There are a number of ways to remember us in your Will:

- **Residuary** – The amount of your estate leftover after you have taken care of your loved ones first. This could also be a percentage. As little as 1% can make a real difference!
- **Pecuniary** – A set amount of money you wish to leave.
- **Specific** – A specific item you wish to leave.

## What to do next

Please do not hesitate to get in contact with us to discuss remembering us in your Will. If you have already made a Will you can easily include us by means of completing a codicil, details of which can be found on our website or obtained from reception at the Centre. If you would like to leave a gift to us in your Will, please ensure that you quote our full name "RSPCA Danaher Animal Home" and charity number 1112369.
